



**RELEASE AND WAIVER OF LIABILITY  
HAVANA TRIATHLON 2018**

The undersigned, in my own right, expressly stated that it is my wish to participate in the event entitled "Triathlon of Havana, Ibero-American Triathlon Championship", to be held in Havana, Cuba, on 24 and 25 February 2018, I also undertake and obligate not to enter any RESTRICTED AREA (S) (understood as that which requires the express authorization through the issuance of a credential or permission by the organizing committee, due to the above when signing the Present written document I accept each and every one of the terms and conditions stipulated in this writing:

1. It is expressly understood that in order to participate in the EVENT, I must mediate my registration to it, in accordance with the procedures that for that purpose the organization has published on its website (www.triathlonhabana.com) or in any other medium Which it deems appropriate.

2. I expressly acknowledge that I know the nature of the EVENT as well as the physical capacities and experience with which I have, stating that they are suitable for participating in the EVENT, because of the foregoing expressly stated that I am in perfect physical health as mental to participate in the EVENT and to develop each and every one of the activities that take place within the EVENT. Likewise I declare that I know the development and activities of the EVENT, so in case the Organizing Committee considers that any of them is unsafe or represents a risk for me or the other participants, this may cancel the EVENT without any responsibility For the Organizing Committee; So if I do not take into consideration the instructions issued by the Organizing Committee, I expressly assume the consequences that may result from my omission of attention or action or negligence to the instructions of the Organizing Committee, releasing the Organizing Committee from any responsibility.

3. I acknowledge and expressly accept that: A) the activities carried out during the EVENT are at my own risk, and participation in it; as well as that my admission to areas considered to be restricted, may or may result in physical or mental injury, including partial or total disability, paralysis or even death (jointly RISK); B) these RISKS may be provoked by my own omission, activity or inactivity before or during EVENT, omission, activity or inactivity of other participants in the EVENT, EVENT rules, conditions and distribution of establishments and equipment, or negligence of the persons to whom I hereby release any responsibility in all matters, or of the climatic conditions in the city where the EVENT is held, or the proper performance of the activities in which the EVENT; C) stating that there may be other RISKS for my participation in the EVENT not known by me or that are not yet foreseeable, or that being foreseeable are to my knowledge, I acknowledge and assume, or are derived by accident or force majeure; D)

social and economic losses and/or direct or indirect damages that may result from these RISKS can be severe and permanently modify my future.

4. I expressly declare that it is my will to participate in the EVENT, so that my participation, as well as the entry to a restricted area, will be under my absolute and total responsibility for what in this act I assume each and every RISK, known or unknown, and assume full responsibility for the losses, costs and/or damages that may be derived from my omission, activity or inactivity and even negligence, among others, total or permanent disability, paralysis or even death of the undersigned, even If these are caused in whole or in part by the negligence of the persons to whom in this act I release of any responsibility.

5. I also state that the objects to be used during my participation in the EVENT, such as bathing suit, accessories, tennis, bicycle and any other that is used by me to participate in the EVENT, are my property, so I declare that I have sufficient capacity for the use and exploitation thereof, as well as to release from all responsibility with respect to them the organizers, EVENT officials, their officials and other participants regarding the use, misuse, partial loss or total, indicating in a non-limiting, non-limiting manner, theft, loss or loss thereof, stating that I am the sole responsible for them, indicating in a non-limitative manner, both in the transition zone, wardrobe or any other area of the EVENT, so I do not reserve any action or right against any third party for damages that may be caused to my goods or accessories, agreeing solely and exclusively that the organizers will be responsible for the custody of my bike from the moment it enters the transition zone and until removed after the event within the time limits set.

6. I hereby authorize the organizers and/or those who designate that in case my person suffers an accident due to my participation, activity or inactivity before, during or after the EVENT, I receive the necessary medical care, as well as that I be transferred to the nearest hospital that the organizing committee designate, for the purpose that I am treated, as well as to be supplied with the medication that I consider convenient for my health or, if applicable, the surgical procedure or the necessary medical procedures doing their best to safeguard my health, discharging from all responsibility the organizing committee, its officers, managers, employees for the actions here referred to or for the immediate or future consequences that could be derived by my participation in the EVENT.

7. I hereby expressly release from all responsibility the organizing committee, its officers, managers, as well as any person or employee who collaborates in the organization and development of the EVENT and expressly instructs my relatives or representatives not to exercise any legal action against the organizing committee, its officers, managers, promoters, participants, associations of participants, regulatory organizations or any subdivision thereof, operators, owners, officers, rescue personnel, any personnel in the organization. Sponsors, advertisers, owners and licensees of the permits that are directly or indirectly related to the EVENT, inspectors or technical delegates of the event, watchmen, insurers, consultants

and any other person or entity that has participation or issues recommendations, indications or instructions or that take part in RISKS assessment or loss of control activities related to the EVENT and each of them, their managers, shareholders, representatives, employees, agents, official contractors, agents and employees, organizers, subsidiaries or subsidiaries of the organizers (all referred to purposes of this document, as released) from all liability to me, my representatives, assigns, heirs, and closest family members, from any and all claims, legal actions or damages relating to any harm to me, including but not limited to not limited to death, or property damage, caused or allegedly caused, in whole or in part, by the negligence of the released or otherwise.

8. If I have made a claim against any of the above-mentioned released persons, I agree to indemnify and hold harmless, and, if I do not agree to indemnify and hold harmless any of the above, I, the undersigned or my family, heirs, successors, keep in peace and safe the liberated and each of them from any trial, honorary expenses of lawyers, or experts involved; lost liabilities, damages or costs that they may incur due to legal or other actions taken against any of the foregoing release, regardless of whether the claim is based on the negligence of the released or otherwise.

9. I acknowledge and accept that the registration made is non-refundable for any reason, transferable to any third party, so in case the EVENT is canceled or postponed for any reason, including unforeseeable circumstances or force majeure, indicating in a declarative manner no more limitation, hurricanes, tornadoes, storms, strikes, terrorist attacks or any other that in the opinion of the organizers of the EVENT, endangers my person, I will not be reimbursed the costs that the subscriber has incurred for me participation in the EVENT, in this case, it will not be understood that the cancellation of the event is due to the negligence of the organizers of the event or of the people who participate in the event, so I hereby release all responsibility in this regard Organizing Committee, its shareholders and any of the released persons described in item "6" above.

10. I acknowledge and agree that as a participant of the EVENT, I must carry at all times the number of participant or the accreditation that has been provided by the organizers of the EVENT, provided that such number or accreditation cannot be transferred or exchanged with any third party under no circumstances, so if I do not have the same, the organizers of the EVENT, may withdraw from it, releasing them from all responsibility, as well as giving up any legal action against them for the actions taken in this regard.

11. I expressly authorize the organizers and / or those whom they designate to use my voice and image, whether partial or total, in everything related to my participation in the EVENT, in any way and at any time, expressly renouncing the collection of any amount that could be generated by the aforementioned uses.
